#### **Summary**

During the last Legislative Session, the State amended Wyoming State Statutes §12-4-413 regarding Bar and Grill Liquor Licenses. This recent change amended the population formula for Bar and Grill allocations. Under the previous version of the statute, the City of Casper was issued 13 Bar and Grill Liquor Licenses. All 13 licenses are assigned and 12 are active. Bar and Grill No. 13. Childs Corp dba La Cocina plan to open in October of this year. Under the amended statute, as of July 1, 2023, the city is allowed 19 Bar and Grill Liquor Licenses. This means that as of July 1, there are 6 available licenses. In 2028, the formula will change again and allow for a total of 27 Bar and Grill liquor licenses.

At the July 18<sup>th</sup>, 2023, work session, Council gave direction to start the ordinance change to include "entertainment" in the revenue requirement for bar and grills and to start taking applications. The timeline for the ordinance change and the application period is:

- August 9<sup>th</sup>- Application period opens with anticipated changes in cover letter
- August 15<sup>th</sup>- Establish public hearing for Bar and Grill Ordinance Changes
- September 5<sup>th</sup>- Public hearing and First Reading of Ordinance Change
- September 19<sup>th</sup>-2<sup>nd</sup> Reading of Ordinance Changes
- September 29<sup>th</sup>- Application period closes at 7:59 AM
- October 3<sup>rd</sup>- 3<sup>rd</sup> and Final Reading
- October 10<sup>th</sup>-Council review of applications in work session
- October 17<sup>th</sup>- Establish Public Hearing for bar and grill license approvals for Nov. 7<sup>th</sup> Public hearing
- October 24<sup>th</sup>-Ordinance becomes effective
- Nov. 7<sup>th</sup>- Public Hearing for License Approvals

Staff has built in an extra Council meeting in case any changes are needed and Council chooses to table a reading. The Ordinance will still be effective by the time necessary to award the licenses in public hearing on November 7<sup>th</sup>.

#### Permitting Update:

For the month of July, 3 building permits for new single-family home construction were issued. This brings the total building permits for new single-family residences in the calendar year to 16 with a value of construction of \$9,054,785.00. The Building Division issued 87 Building, 64 Electrical, 53 Mechanical, and 59 Plumbing permits with a value of construction of \$47,052,702.51, and with a permit revenue of \$429,762.41. A large portion of this month's revenue came in from the issuance of the WYO Sports Ranch building permit which is a \$40,000,000.00 project.

#### Calendar year: January 1st through July 31st

Permit total = 2037 permits issued for a value of \$92,912,176.89, and with a revenue of \$1,029,161.10.

#### Fiscal Year: July 1st through July 31st

Permit total = 263 permits issued for a value of \$47,052,702.51, and with a revenue of \$429,762.41.

#### July Inspection Update:

The Building Division completed 186 building, 178 electrical, 138 plumbing, and 46 mechanical inspections, plus 2 plan reviews.

#### Commercial Construction Update:

Below is a breakdown of the 9 major commercial projects that are in progress:

Note: All projects are not included in this list; smaller projects including remodeling, alterations and additions may not be listed.

• LDS Temple (3011 Independence Dr.), Interior connections and finish are in process. Stone veneer is being installed and the steeple structure is being framed. Anticipated completion of this project is the end of August.



- CY Liquior and Backdoor Lounge (1363 CY Ave) Interior framing and M/E/P's are in process.
- Wal-Mart East Interior Remodel (4400 E. 2<sup>nd</sup> St.) Fire pump and sprinkler piping in process.
- Casport Mint, (170 Star Lane), Phase I is nearing completion. A T.C.O. for Phase I has been scheduled for August 7th.
- Nolan Phase II (225 S. David St. Condominiums), Interior and exterior finishes are in process for all three units. Phase III foundation is in process.
- Jump Craze (SE Wyoming Blvd near E 21<sup>st</sup> St), The permit has been issued. Site work structural steel is in process.
- Discount Tire (4990 E. 2<sup>nd</sup> St near the Residence Inn), Site work is in process and the foundation has been poured, CMU walls are in process.
- 307 Chiropractic (5980 Enterprise Dr near Menards), Site work is in process and the foundation has been poured. Framing and M/E/P's are in process.
- City Hall Project SAFE (200 N David St), Asbestos abatement and interior demolition is in process.

To provide information regarding the response to wildlife and nuisance animals by Metro Animal Control Officer.

#### **Summary:**

Metro Animal Services' primary responsibility is to ensure the safety and welfare of domestic animals and humans within our jurisdiction. Metro Animal Control has been called to assist in numerous wildlife complaints regarding predatory animals as defined in "WSS 23-1-101A. i-viii": (Coyote, jackrabbit, porcupine, raccoon, red fox, skunk, or stray cat). Animal Protection officers do not have jurisdiction over game animals and will refer those complaints to the Wyoming Game and Fish. Metro Animal Control officers will refer nuisance animal complaints, that do not pose a threat to public safety, out to private pest control companies and provide guidance on how to reduce the conflict with wildlife.
