# 8.A. <u>PUBLIC HEARING – MINUTE ACTION</u>

City Attorney Nelson entered four (4) exhibits: correspondence from Fleur Tremel to J. Carter Napier, dated January 4, 2024; an affidavit of website publication, dated January 4, 2024; Casper Star-Tribune Proof of Publication, published on January 4 & 9, 2024; and a liquor license application filed December 20, 2023. City Manager Napier gave a brief report for this item as well as the next public hearing.

There were no citizens to speak for or against the item. The public hearing was closed.

Moved by Councilor Gamroth, seconded by Councilor Haskins to, by consent minute action approve the transfer of ownership interest & name change for Retail Liquor License No. 10 from Armor's Restaurant, Inc., dba Silver Fox Steakhouse, located at 3422 Energy Lane, to Silver Fox Restaurant and Lounge, dba Silver Fox Restaurant and Lounge, located at 3422 South Energy Lane. Councilor Gamroth asked about a trust owning the license, and City Attorney Nelson responded that a trust is a legitimate holder of a liquor license. Vice Mayor Engebretsen asked about the timeline for a transfer, and City Attorney Nelson responded that this change was based on the estate and that there is not a hard and fast timeline. Councilor Pollock abstained from voting on the item. Motion passed.
